

## Dyna-Mac Recognised for Highest Shareholder Returns (3 Years)

- Dyna-Mac wins The Edge Singapore's Centurion Club 2024 Highest Returns to Shareholders Over 3 Years Award

**SINGAPORE, November 07, 2024 – Dyna-Mac Holdings Ltd (SGX: NO4) (“Dyna-Mac” or the “Company” and together with its subsidiaries, the “Group”)** is pleased to announce that the Group has won The Edge Singapore's Centurion Club 2024 – Highest Returns to Shareholders Over Three Years Award within the Applied Resources + Chemicals + Energy – Fossil Fuels + Mineral Resources + Renewable Energy + Utilities sector.

The Edge Singapore's Centurion Club awards recognise excellence in companies listed on Singapore Exchange (SGX) with a market capitalisation between \$100 million and \$999 million. The selection of winning Centurion Club companies is based on published, measurable metrics of the companies in their respective sectors. These metrics include profit after tax (PAT) growth, return on equity (ROE) and returns to shareholders over the last three years.

This prestigious accolade underscores Dyna-Mac's notable financial performance. Over the past three years, the Group has demonstrated extraordinary growth, with **revenue** achieving a **compound annual growth rate (CAGR) of around 32.3%, rising from S\$220.2 million in FY2021 to S\$385.2 million in FY2023**. This consistent growth trajectory highlights Dyna-Mac's expanding market presence and its ability to secure high-value projects.

The Group's robust financial performance is further reinforced by its annualised return on equity (ROE), which has **more than tripled from 18.5% in FY2021 to an impressive 66.4% in 1H2024**. This strong ROE demonstrates Dyna-Mac's efficient capital management and its capability to deliver substantial returns to shareholders, positioning it as one of the top-performing companies in its sector.

Dyna-Mac's **net profit** has grown at an even more impressive pace, with a **three-year CAGR of approximately 128.1%, surging from S\$5.5 million in FY2021 to S\$28.5 million in FY2023**. This noteworthy increase in profitability reflects the company's focus on operational efficiency and strategic project execution, driving significant value creation for its shareholders.

The Edge Singapore's Centurion Club 2024 award is a testament to Dyna-Mac's unwavering dedication to growth, operational excellence, and maximising shareholder value. As the Group continues to expand and innovate, it remains committed to sustaining this robust momentum and delivering long-term value for all its stakeholders.
